The Shankharapur Municipality, Office of the Municipal Executive has allocated funds towards the cost for construction as indicated in details of work below and intends to apply part of the funds to cover eligible payments under the contract for construction as indicated in details of work. Bidding is open to all eligible Nepalese bidders.
2. The Shankharapur Municipality, Office of the Municipal Executive invites **Electronic bids** under **NCB–Single Stage Two Envelope Bidding** procedures from eligible bidders for the construction as indicated in details of work below as in accordance with **e-GP Procurement Directive 2074**. Eligible bidders with the following key qualifications should participate in this bidding and may obtain further information and inspect the Bidding Documents through PPMO website www.bolpatra.gov.np/egp

Key qualifications for S. N. 1 works:

- a) Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 20.57 Million excluding VAT**
 - b) Minimum Work experience of similar size and nature: *one number of RCC Frame Structure Building project within last 10 years with value of NRs. 15.54 Million excluding VAT*
3. A complete set of Bidding Documents may down load from PPMO's Web Site www.bolpatra.gov.np/egp by eligible Bidders and submit their bids only electronically through www.bolpatra.gov.np/egp and upon payment of a non-refundable fee as shown in table below in the Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank Deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Bidding documents can be down loaded from PPMO's web site or purchased within the office hours on or before **Ashar 01, 2077 (15 June, 2020)**.

5. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a scanned copy of the Bid security in pdf format amounting as specified in the details of works, which shall be valid up to **30 days** beyond the validity period of Bid.
6. Pre-bid meeting shall be held at Shankharapur Municipality, Office of the Municipal Executive, Sankhu, Kathmandu at 13.00 hrs. on **Jestha 23, 2077 (05 June, 2020)**.

7. Electronic Bids must be submitted through PPMO website www.bolpatra.gov.np/egg on or before **12:00 hrs of Ashar 02, 2077 (16 June, 2020)**. After that time web site will not accept automatically any bids submitted late.
8. The **Technical Bid** will be opened in the presence of Bidders' representatives who choose to attend at **13.00 hrs. of Ashar 02, 2077 (16 June, 2020)** at Shankharapur Municipality, Office of the Municipal Executive, Sankhu, Kathmandu.
9. The **price Bid** will be opened after evaluation of Technical Bids. The e-GP system will send the e-mail notification to bidders whose price bids which have been found substantially responsive Technical Bids and who have been determined as being qualified for award to attend the opening of the Price Bids.
